In our last fiscal year, our services directly impacted 60,817 animals through a connected network of veterinary care, sheltering, and outreach. We provided medical treatment to 4,536 animals, performed 6,235 spay/neuter surgeries, and distributed over 1.1 million pet meals to families and shelters in need. We also supported families in urgent need by providing emergency boarding, veterinary care, and reunification services. These aren't just services... they're life-changing interventions that keep animals safe, healthy, and with the people who love them.

We amplified this work with targeted communications, public outreach, and our Day of Giving to unite our city in defense of the defenseless through action, awareness, and heart.
